



## REPORT ON THE TREASURY SHARES BUY-BACK PLAN OF PIQUADRO S.P.A.

**Silla di Gaggio Montano (BO), January 11 2021** - With reference to treasury shares buy-back plan, Piquadro S.p.A. hereby announces that, during the period from January 4<sup>th</sup> to January 8<sup>th</sup>, 2021, it purchased no. 15,633 treasury shares for a total consideration of 23,563.78 Euro, as authorized by the shareholders' meeting on September 10<sup>th</sup>, 2020, already disclosed pursuant to Art. 144-bis of Consob Regulation no. 11971/1999.

The distribution network extends over 50 countries around the world and counts 177 outlets including 85 Piquadro boutiques (56 in Italy and 29 abroad; 49 DOS directly operated stores and*
